Motion Made Donovan Saunders, 2<sup>nd</sup> David Blair, Treasurers approved with no exceptions.

Motion Made Beth Anderson, 2<sup>nd</sup> David Blair, Bill for RD Zeulli dated 01/02/2025 for \$43,900.58 to be held at the recommendation of Beth Ann Grasso until at least next month, bills approved.

Lynn asked if the 91,000 completes the payment for the 153,000 for the new spillway? Steve said yes. Lynn then asked what the additional bill for the 43,000 is for? Additional work that is being done at the other end. They did complete the trash gate, railings, the pinning of the dam.

Beth Anderson found the invoice, the bill is for \$1700 the temporary access , \$5700 for site improvements and earthwork, \$30,000 for spillway repairs and modifications,\$6500 for restoration. This is for the spillway. Steve said he doesn't want to pay it until he can have clarified exactly what the bill is. He is going to talk to Chris from Zeulli, or the foreman out there.

### **Committee Reports**

# <u>Dams</u>

They have driven the steel plates front of the diversion pipes. They ran into an issue with the first piece of equipment they had out there, they replaced it, the plates started to drive down easily, the second machine broke, when Donovan was out there they were replacing the part so they could continue drive the plates down. He hasn't been back, but they said there will be no issue with driving the rest of the plates down.

Steve spoke with Jim at the site, Jim said that the concrete guy Tommie was supposed to be there today January 6 and complete the Wier Wall, which is the wall against the water towards the beach. That has to be put in along with the ACBs, once that is in the Dam other then turning the ACBs, the Dam would be complete. Steve sent an email to Beth Ann Grasso to get on the contractor and the manufacturer of the AVBs, because he is not satisfied with the results that we have been getting as far as how many do we have to turn 180 degrees. Steve received an email today which was sent to the contractor and the manufacturer to get this done. This was forwarded to all of the board members and Dam Committee. So before they finish laying the ACBs which should only take about 7 to 10 days total to complete all of the concrete work and place the ACBs. So your 7 to 10 days away from completion with the exception of turning whichever ACBs need to be turned.

The fence work was completed, the trash gate is in and holding back a lot of trash. That is why the lake is getting full, because the trash gate is blocking the sleuth gate. Donovan said that Zeulli cleared the trash gate on Thursday or Friday and more trash was already starting to accumulate. Steve said once the Sleuth gate is closed, everything will go over the top of the dam. AS far as the rest of the work goes it looks great and the Gavian Mats are going to work great. The water is staged the way it is supposed to come out of the sleuth box itself so it actually trickles down like a waterfall in 2 stages, so the water actually trickles down. It does a really good job at it.

Donovan was asked to describe the ACB blocks are? Donovan said they are the blocks that make up the secondary spillway, they are tied together with cable and creates a concrete block mat. The little nubs have to be facing the lake. We need to know how many to spin around. There is about 6 to 10 to be complete. It was asked if we could contact the manufacturer about how the mats are supposed to be placed. Steve said he is trying to get Beth Ann to do that, that would be ideal. The manufacturer has already made a recommendation, Beth Ann has not weighed in on it, she has liability there as well, so Beth Ann Grasso has to decide if she is ok with that in conjunction with the manufacturer. Beth Ann stated she has received a verbal recommendation and she wants the recommendation in writing so there is nothing coming back on Collings Lake, Zeulli or Beth Ann. Manufacturers specifications supersede all codes. So it has to be in writing, and we have only received a verbal recommendation.

#### <u>Grounds</u>

The tree removal between 2<sup>nd</sup> and 3<sup>rd</sup> beach has been completed and around the perimeter of the lake. We had about 6 people come out to help, so not a great turn out, but we did get a lot of trees cut out and cleared and as much as we could.

### **Fundrainsing**

There is a spring online fundraiser through flower power fundraising, the link will be on our social page and get some fliers out. If we sell over \$500.00 we get 50% if we sell less, we get \$40%. It is open until March 15, they will ship bulbs seasonal.

# Presidents Report

ACV are scheduled to take over, so invoices and ballots for the by-law changes will be mailed at the same time to all residents.
